PUBLIC COMMENTS

Shane Morris, Berea

Asked the City to reconsider permits being issued for City events and/or partisan rallies.

Jacque Bowling, Berea

Expressed disappointment of events supported by the City over the past weekend suggesting Berea's image was being destroyed as the Arts & Craft Capital of Kentucky.

Eleanor Workman, Berea

Felt it was dangerous to have declaratory statements made of a personal opinion and inappropriate at City Council meetings to bring up one's own particular religious beliefs and put labels on other people.

John Coyne, Berea

Although we all have the right to our own beliefs, there was a tenor of condemnation of fellow citizens from other speakers. Reminded Council of the principle of separation of church and state and they were there to serve everyone in a manner to keep that separation.

Margaret (Peggy) Coyne, Berea

Agreed with Mr. Coyne. Addressing the Fireworks Ordinance, due to the nature of the ordinance regarding veterans with PTSD issues, etc., felt the ordinance should be addressed separately, more quickly and thoroughly and not woven into another ordinance. Expressed the danger of Highway 21, appreciated that the ball was rolling to do something about the danger(s) and urged Council to expedite any project they could.

REQUEST FOR STRONGER FIREWORKS ORDINANCE - Jackie Pullum

As working with people from all types of traumatic situations, it was very common for people who have experienced an extremely traumatic event to be affected by sudden loud noises, i.e., fireworks, modified cars, exploding transformers, etc. The current city ordinance allowed for a broad understanding of when, where, and what type of fireworks used within City Limits. Many members of the community would like to see the ordinance changed to represent the value of our City and benefit from knowing when fireworks would be happening. Fireworks also affected domestic and wild animals. During the month of July, not only did fireworks cause incredible fear in animals, more animals became injured or missing more than any other time of the year. Plead for a revision that allowed celebration(s) on the deserving holidays, not 365 days a year, and to reconsider the types of fireworks the public was allowed to use. Hoped everyone could look at the ordinance with an open mind, take the time to consider and respect the people in the community, making it fitting for everyone.

DEPARTMENT HEAD REPORTS

Donna Angel, Business & Tourism Development Director

Business Development

As of January 2022, shared forty-three (43) businesses which had opened and/or opening soon in Berea.

Current Projects included a bank to come in late October, Popeyes was on target to open in November, a Lexington steakhouse was visiting sites in Berea, AppHarvest continued to hire and train, gearing up for a job fair for Hitachi Astemo Electric, Novelis (Kevin Brown) and Hitachi Astemo Electric (David Edwards) had new plant managers, and MP Kelly's building project was moving along for wrap-up in October.

Future Projects included the development of a new digital Economic Development & Community profile package about Berea for providing to future prospects.

Tourism

Completed Projects included Festival of LearnShops wrapped up successfully, Fall & Winter ads were ready for print magazines, two of four new video shoots of outdoor Berea, Guest Relations Conference for Motorcoach Specialists, Chestnut Street Pavilion Music Series, bookings for 2023 Motorcoach Conferences (Louisville, Ohio, Detroit, West Virginia), and IT upgrades for Tourism.

Current Projects included Trolley Bus search, digital video sign/reader board for the Pavilion, new board wrap for Tolle Building wall sign, Make It - Take It - Give It classes scheduled through November, ordering Halloween in the Park candy, National Tree Week, Christmas Planning, decorating of Old Town by November 22nd, Small Business Saturday & Shop Small Saturday, Merry Mingling & Tree Lighting Ceremony, including Santa.

Future Projects included preparation for the Japan Sister City Program in November, scheduling for a 2023 Berea Craft Festival Meeting in October, Berea was selected to participate in hosting a State Tourism International Tour of Travel writers in Berea (along with Lexington & Paducah), Day Trip Tours with Antique Trails and Urban Farm lunches on site, Kentucky Travel Industry Association (KTIA) Conference in November (Lexington), Southland Travel Services (STS) Conference in November (Louisville), Heartland Motorcoach Conference in February (Ohio), and American Bus Association (ABA) Conference in February (Detroit).

Angel also noted, as of today, Berea was listed as one of the top seven most beautiful towns in Kentucky by World Atlas Rediscover, with Berea listed as number one.
