PUBLIC COMMENTS

Jacquelyn Bowling, Berea

Stated City Councils members were there to serve the citizens. Per the First Amendment, shared her freedom to voice her opinions without opposition. She would use her knowledge to bring things to light, would fight for what was right until found to be wrong, and would continue until no longer here.

Eleanor Workman, Berea

As it was election time, she was glad to be in Berea. Sensible people were running for office and appreciated that she had not heard any 'bad-mouthing' one another. When voting, she voted for individuals who did their work/homework and shared information, which provided good results.

FARRISTOWN COMMUNITY UPDATE - Aaron Banther

Thanked Mayor Fraley and the City Council for taking the time to meet with the Farristown Community earlier this year, realizing changes needed to be made. He was looking for continuous solutions that would not drive people apart but bring them together. As of June 2nd, there had been two community meetings, a meeting with Berea Home Village, a grant was received from the Kentucky Historical Society to gather rural history regarding Farristown, had received good news from the Kentucky Transportation Cabinet on the progress of the Farristown Bridge, would like to see a student(s) from Farristown Middle School involved in community engagement, the Farristown Church and Cemetery were in the process of getting cleaned up, an access way was to be provided to the Farristown Cemetery, and funds were being raised for a Community Welcome Center. As far as Industrial Development involvement, he understood jobs, roles, and giving opportunities within the city, but would honestly prefer Farristown would stay the way it is. At the very least, with economic growth, the safety of the citizens should be number one over economic growth. A buffer zone between what was being built and the residents would be respectful. Requested other citizens help him to be a part of the

historical preservation. Appreciated that three acres of the eighty-seven acres, purchased by the City, would be designated for a green space dedicated to the families of Farristown. Keep Farristown in conversation and don't forget about them.

<u>AUDIT REPORT - Baldwin CPAs, LLC, Drew Ulmer, Myron Fisher</u>
Ulmer, CPA/Manager, Baldwin CPAs, LLC, presented an overview of the completed audit for fiscal year 2022. Audit went as planned with no audit issues nor internal control deficiencies. The results were a clean audit for the City of Berea.

DEPARTMENT HEAD REPORTS

Shawn Sandlin, Fire Chief, Berea Fire Department

Sandlin reminded everyone that the Fall Fire Season ran from October 1 thru December 15 in which NO open burning was permitted between the hours of 6am and 6pm, if you were near any woodland or brushland areas. If anyone had plans to have a controlled burn, they would need to contact the Fire Station to obtain guidance prior to lighting a fire.

The Fire Department was currently heavily involved in fundraising for their Christmas Toy and Breast Cancer Awareness Programs. Both programs were ran by off-duty firefighters with support from on-

duty firefighters when time allowed.

Current daily duties / training included: Calls for Service (CFS) were currently trending to top last year's 826 calls, Annual Pump Testing would be completed next week, Ladder Testing was scheduled for mid-November, National Fire Protection Association (NFPA) compliant physicals were scheduled for the first week in November, all 55 self-contained breathing apparatuses & 85 cylinders had been certified, over three miles of fire hose had been tested, and annual maintenance on each apparatus had been completed, approximately ninety business inspections (pre-planning) were completed each month, testing for 355 fire hydrants had been completed, had participated in over sixty public relation events to date, and completed Fire Prevention Week during the month of October.

Interagency Active Shooter annual training for firefighters was mandated by the Kentucky Fire Commission had been completed last week. Twelve members would complete their recertification

training for Emergency Medical Technician (EMT) in October.
Sandlin stated the City had an amazing group of firefighters that loved their jobs and always willing to step up and fill in during any situation that was needed. It was an honor to lead such a group. Thanked all City Departments for what they do as they worked closely with all departments. Sometimes they were there first, sometimes they were all together, but it had always been great to share a common goal...to help each citizen when they need it the most.

Sandlin noted, in collaboration with the Police & other city departments, they were currently working on

a Coat Drive for Eastern Kentucky, specifically the area of Hindman, KY.

Sandlin complimented City Administrator, Rose Beverly, on an excellent job within the past year.

Susan Meeks, Finance Director

Meeks introduced Berea Municipal Utilities (BMU) customer notification system, residential and business, soon to be implemented. The system would enhance the City's communication with customers by offering the most up-to-date information regarding utility services provided by BMU. With the system, customers would receive information on scheduled power outages, interruption of water service, and boil water advisories via text messages or automated voice messages on their landlines. To receive the information, customers would need to sign up for the service through the billing office.

CITY ADMINISTRATOR'S REPORT - Rose Beverly

- Waiting on a bid and date for street striping. The Allen Company would be striping Forest Street and currently waiting on a date for completion.
- The street Capital Improvement Plan (CIP) was scheduled to be completed by Thanksgiving.
- Working on the final details for Ellipse Street. The project was scheduled to be let in February 2023 with plans for completion in April or May, weather pending. Extra funding would be provided by the Federal Government due to project being held up on the state level.
- Berea Tourism LearnShops announced the "MAKE IT, TAKE IT, GIVE IT" holiday classes would begin this weekend and would run through November 27th.
- Fall Clean-Up was underway this week.
- The 21st Annual Halloween at the Park was scheduled for Monday, October 31st, 6:00 p.m. –
 8:00 p.m., free event.

- Nice to have a clean audit. Thanked the Financial Management Team, City Council, and all involved. Well done.
- Complimented Banther on his historical preservation and grassroots community building, a natural gift. Appreciated the work he was doing as Farristown history was also Berea history.
